2019 Afterschool Programs Scholarship Application

Afterschool programs (Open Program or Development Clinic) offers a limited number of scholarships each semester. Scholarships are awarded based on need and on a first-come, first-served basis. Submission of a scholarship packet does not guarantee a scholarship.

- Type of Scholarships are available:
 - Partner Scholarship: Parent pays half of the registration fee for the program
- Scholarship applications will not be considered until online registration is complete and all appropriate attachments have been submitted.
- Once a scholarship application has been received, families will be notified within one week as to the status of the application.
- Once a scholarship is awarded, families will have one week to submit the partial payment.

To submit a scholarship packet:

- Complete online registration and select the session to which you would like to apply this scholarship.
- Complete and submit the scholarship application along with requested documentation. Incomplete packets will not be considered.
- Required documents include:
 - □ A copy of the parents', the custodial parents or the guardian's (select one)
 - □ Form 1040 pages 1 & 2
 - □ Form 1040A pages 1 & 2
 - □ Form 1040EZ page 1
 - □ TANF or SNAP Approval letter (Letter can be no more than 12 months old)
 - □ Medicaid card (with proof of current enrollment)
 - A statement from the child explaining why they would like to participate in the Lobs & Lessons program. This must be handwritten by the child, not to be completed by the parent/guardian.
 For 2nd graders, a drawn picture can be submitted instead.
- The completed scholarship applications must be accompanied by all required documents and may be faxed, emailed, mailed or submitted in person.
